SOFTWARE LICENSE AGREEMENT

- Grant of License.** **LMXFORGE** grants the purchaser a **non-exclusive, non-transferable license** to use this software for internal design, drafting, and estimating work. The purchaser may install and use the tool on their own workstation(s) as needed for their projects.
- License Types.** Individual License is the use by one person on one workstation. Firm License is the use by multiple employees within the same company. Redistribution outside the licensed company is not permitted.
- Restrictions.** The purchaser may not, under any circumstances:
 - Share, resell, distribute, or transfer any part of the software package (Excel workbook, LISP files, FAS files, or documentation) to third parties.
 - Modify, edit, or alter the Excel workbook structure, formulas, protected sheets, or embedded logic for the purpose of redistribution or creating derivative commercial products.
 - Decompile, reverse-engineer, or attempt to extract source code from the compiled AutoCAD FAS modules or LISP automation scripts.
 - Upload or publish the Excel workbook, LISP/FAS files, or any portion of the software to public repositories, cloud drives, or file-sharing platforms where unauthorized users may access it.
 - Claim authorship or ownership of the Excel workbook, AutoCAD automation scripts, or any part of the software package.
 - Use the software to create competing commercial tools that replicate or repackage its functionality.
- Intellectual Property.** All rights, title, and interest in the software remain the property of **LMXFORGE**. Purchasing a license does not transfer ownership of the source code or compiled files.
